Subject: Additional Information for License Renewal

Discussion: There were some questions that arose when reviewing the license application that did not require a formal request for additional information so I emailed Sharon Long, the Health Physics Consultant for SRMC and then followed up with a phone call to Radiation Safety Officer. The following items were addressed:

1. I confirmed that Halberto G. Cruz, M.D. should not be listed as an authorized user.
2. I confirmed that no PET radiopharmaceuticals were in use or planned for use.
3. I confirmed that they did not possess any sealed sources greater than the activity allowed by 10 CFR 35.65.
4. I asked for justification for increasing the limit for 35.300 since they had not conducted therapies in years. They agreed to maintain the limit at 500 millicuries.
5. I discussed the room diagrams submitted. It did not appear that they submitted what was above and below. I confirmed that below Nuclear Medicine is earth and above is Pediatrics offices. For the fourth floor stress lab, there is nothing above and below is Pediatrics offices.
