In response to the above referenced Notice of Violation, dated March 3, 2016, we are requesting an additional 30 days to complete our review of the violation and review the information that was submitted to us under our FOIA request dated January 19, 2016.

Although the notice of violation is dated March 3, 2016, it should be noted that an electronic copy was not sent to us until March 7, 2016; with the resulting hard copy being received by US mail on March 16<sup>th</sup>. Additionally, our initial FOIA request was made on January 19, 2016; with the requested documentation not being received until March 17<sup>th</sup>, 2016.

After initial review of both documents, we believe that information provided through our FOIA request will have an impact on how we proceed regarding the final disposition of the above referenced violation and request additional time for review and disposition.
