SUBJECT: RECOMMENDATION AND REQUEST FOR APPROVAL OF
MATERIALS DECOMMISSIONING PROJECT MANAGER
QUALIFICATION FOR JAMES SMITH

As provided for in Section 1248-07 (Qualification Journal Completion) of the U.S. Nuclear Regulatory Commission (NRC) Inspection Manual Chapter (IMC)-1248, "Formal Qualifications Program for Federal and State Material and Environmental Management Programs," dated April 18, 2013, this memorandum recommends that Mr. James Smith be granted qualification as a Qualified Materials Decommissioning Project Manager. Furthermore, I have determined that no Qualification Board was needed.

Mr. Smith was qualified as a Fuel Cycle Project Manager in 2004, in the Office of Nuclear Material Safety and Safeguards, Division of Fuel Cycle Safety and Safeguards. Additionally, he has completed the following materials decommissioning related courses: 1) Advanced Health Physics (H-201); 2) Multi-Agency Radiation Survey and Site Investigation Manual (H-121); 3) RESRAD (H-410); 4) The Princeton Groundwater Pollution and Hydrology; 5) The Argonne National Laboratory's Facility Decommissioning; and 6) Environmental Monitoring for Radioactivity (H-111).

I have determined that a Qualification Board under Section 1248-08 of IMC-1248 was not needed because he possesses sufficient knowledge, education, skills, abilities, and prior experience as evidenced by his previous qualification and his approximately 26 years of experience at the NRC. He has demonstrated knowledge and application of NRC requirements, policies, Management Directives, guidance and review procedures, and office and division procedures in his many technical and management reviews.
