As the changes are editorial, staff concludes that they do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

## **EVALUATION**

On January 29, 2016, staff issued CoC No. 9342, Revision No. 11, for the Model No. Versa-Pac transportation package. Staff is issuing Revision No. 12 of the CoC to correct inadvertent editorial errors.

The changes are specified in the, "Conditions," section below. Corrections have been made to the table numbering and text formatting.

As the changes are editorial, staff concludes that they do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

## **CONDITIONS**

Condition No. 5(a)(2), "Description," has been updated to add, "Table 1 - Weight and Dimensions" for the previously unlabeled table.

Condition No. 5(b)(2), "Maximum quantity of material per package," has been updated by changing, "Table 1 – Loading Table for Model Nos. VP55 and VP-110," to, "Table 2 – Loading Table for Model Nos. VP55 and VP-110." Additionally, "Table 2-1A - Loading Table for Model No. VP-55HC," has been changed to, "Table 3 - Loading Table for Model No. VP-55HC."

Condition No. 5(c), "Criticality Safety Index (CSI)," has been reformatted to include the CSI in the title of the condition.

## **CONCLUSION**

Based on the statements contained in the application, and the conditions listed above, the staff concludes that the changes indicated do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
