SUBJECT: PART TIME EMPLOYMENT AS A BRIDGE ENGINEER

Stantec Inc. has asked me to perform part-time duties as a bridge engineer. Stantec Inc. is a holder of the U.S. Nuclear Regulatory Commission (NRC) license 47-35105-01 (docket 030-38686) in the State of West Virginia (Non-Agreement State) for the possession and use of nuclear gauge(s), and has a license with the State of Pennsylvania (Agreement State) and possibly others. I am requesting your authorization to engage in this outside activity during after duty hours and I am providing the following information:

1. Antonio Rigato, Structural Engineer.
2. My duties at the NRC are as a technical reviewer (structural) in the division of Spent Fuel Management, Office of Nuclear Material Safety and Safeguards in the Containment Structural and Thermal Branch.
3. My duties would involve bridge inspection, bridge inspection report writing, performing design calculations, and design checking. These duties do not involve the use of the aforementioned nuclear gauge, the licensing of the gauge, or any amendment activities related to the license 47-35105-01.

5. Compensation is estimated to be between 40-50 US dollars an hour.
