**Clinton Operational Safety Review Team (OSART) Report**

By letter dated March 2, 2016, Exelon Generation agreed to make the final International Atomic Energy Agency (IAEA) OSART report for the Clinton Power Station publicly available on NRC's Website. The staff will make the report publicly available as soon as the document is de-restricted by the IAEA. The IAEA conducted an OSART mission at Clinton from August 11-28, 2014, and a follow-up mission from October 26-30, 2015.
