If for any reason your request cannot be completed, NSIR/DSO/ISB will inform you of your appeal rights. The NRC may refuse to confirm or deny the existence or nonexistence of the requested information whenever the fact of the existence or nonexistence of the information is, itself, classified. If the requested information concerns other U.S. Government agencies, those agencies will provide separate reviews.
