**SUBJECT: U.S. NUCLEAR REGULATORY COMMISSION INSPECTION  
REPORT 70-3103/2015-404 SYNOPSIS**

Dear Mr. Laughlin:

This letter refers to a follow-up inspection conducted by the U.S. Nuclear Regulatory Commission (NRC) onsite from October 26-30, 2015, and an in-office review completed February 11, 2016, regarding events associated with your security program at the URENCO-USA (UUSA) site in Eunice, NM. The Special Inspection report (IR) 70-3103/2014-006 was issued on May 29, 2015. The purpose of the on-site inspection and in-office review was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. The preliminary results of the NRC onsite inspection and in-office review were discussed with members of your staff on February 9, 2016, and during a subsequent telephone meeting on February 11, 2016.

Based on the results of the inspections, apparent violations (AVs) of NRC requirements were identified and are being considered for escalated enforcement action in accordance with NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's Web site at (<http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>).

The NRC determined that the immediate corrective actions developed in UUSA's Root Cause Evaluation (RCE) appear to be adequate to address the failed barriers identified by both UUSA's staff and the NRC inspectors. Please be advised that the NRC has not fully assessed the adequacy and comprehensiveness of corrective actions to preclude similar AVs.

Before the NRC makes its enforcement decision, we are providing you an opportunity to request a Pre-decisional Enforcement Conference (PEC). If a PEC is held, the NRC will conduct this conference as a closed meeting due to the security-related information and the potential for classified discussions. If you decide to participate in a PEC, please contact Marvin Sykes at 404-997-4629 within 10 days of the date of this letter. A PEC should be held within 30 days of the date of this letter.

If you choose to request a PEC, the conference will afford you the opportunity to provide your perspective on these matters and any other information that you believe the NRC should take into consideration before making an enforcement decision. The decision to hold a PEC does not mean that the NRC has determined that a violation has occurred or that enforcement action will be taken. This conference would be conducted to obtain information to assist the NRC in making an enforcement decision. The topics discussed during the conference may include information to determine whether a violation occurred, information to determine the significance of a violation, information related to the identification of a violation, and information related to any corrective actions taken or planned. In presenting your corrective actions, you should be aware that the promptness and comprehensiveness of your actions will be considered in assessing any civil penalty for the AVs.

Since the NRC has not made a final determination in this matter, no Notice of Violation (NOV) is being issued for these inspection findings at this time. In addition, please be advised that the number and characterization of the AVs described in the enclosed inspection report may change as a result of further NRC review.
