Dear Mr. Bergman:

In a February 4, 2016, letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16039A037), Mr. Zackary W. Rad, Director, Regulatory Affairs, NuScale Power, LLC (NuScale), requested that the following material be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- NuScale Submitted “NuScale Nuclear Analysis Codes and Methods Qualification Topical Report” Revision 0, PM-0216-21523-P for use during a closed meeting on February 18, 2016, (ADAMS Accession No. ML16039A041).

A non-proprietary copy of the presentation slides and the affidavit have been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS at the following accession number:

- NuScale Submitted “NuScale Nuclear Analysis Codes and Methods Qualification Topical Report” Revision 0, PM-0216-21523-NP, Non-Proprietary Version (ADAMS Accession No. ML16039A038).

In the February 4, 2016 letter, the affidavit (ADAMS Accession No. ML16039A040) stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information presented and discussed.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the NRC staff may send copies of this information to our consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
