Labor, Administrative and Equipment Moving Support Services

On April 6, 2016, contract number NRC-HQ-40-16-C-0006 was awarded to Proven Management, LLC in Greenbelt, Maryland. The purpose of this contract is to provide NRC Headquarters locations and on rare occasions, the Regional offices and the Technical Training Center, with ongoing support services for a wide variety of administrative, warehousing, moving, furniture installation, and other labor as needed. The period of performance is from April 6, 2016, through April 30, 2017, with four option years. The total potential value over the life of the contract is \$3,091,963.

Architectural and Engineering Contract

On April 6, 2016, Enterprise-Wide Contract number NRC-HQ-40-16-E-0002 was awarded to AE Works, LTD in State College, Pennsylvania. The purpose of this contract is to provide architectural and engineering (A&E) services to support NRC's long-term housing strategy and NRC's restoration and refurbishment activities. The period of performance is from April 6, 2016, through April 6, 2017, with four option years. The total potential value over the life of the contract is \$5,500,000.

Cyber Security at Fuel Cycle Facilities: Final Regulatory Basis; Availability; Part 73 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ64; NRC-2015-0179)

On April 12, 2016, the NRC published a final regulatory basis in the *Federal Register* ([81 FR 21449](#)) that supports a rulemaking that would amend the NRC's regulations by adopting new cyber security requirements for certain nuclear fuel cycle facility licensees to address safety, security, and safeguards consequences of concern. The NRC did not seek public comment on the regulatory basis.
