

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the level of effort for Tasks 5, 6, and 8 to accommodate additional contractor support, and to change the Contracting Officer's Representative (COR) from Ms. Mirabelle Shoemaker to Ms. Jessie Muir-Quintero. This additional contractor support is due to delays in receiving new and revised application information from the applicant, and the increase in the level of detail for the geology and water resources sections of the Marsland environmental assessment (EA). As a result (1) the estimated cost plus fee of this task order is hereby increased by \$53,997.43 from \$509,811.65 to \$563,789.08, and (2) Ms. Mirabelle Shoemaker is hereby replaced as the COR by Ms. Jessie Muir-Quintero (301-415-7476, Jessie.Muir-Quintero@nrc.gov).
