

Materials imported that need to be returned must include those which cannot be recycled for beneficial reuse, or do not conform to specification, or have been processed for volume reduction, or are wastes directly attributable to processing materials imported. DESCRIPTION OF MATERIALS OR FACILITIES: (Cont'd)

License is amended to: 1) change the supplier name from Duratek Services Inc., to EnergySolutions Services, Inc.; 2) change the point of contact from Phillip Gianutsos to Duane R. Quayle; 3) change supplier/consignee from Monserco Limited to EnergySolutions Canada, Inc.; 4) add two additional U.S. consignees; 5) increase activity commensurate with increased weight from 6,000 to 10,000 tons; 6) grant relief from package restrictions; 7) grant relief from waste classification per 10 CFR Part 61, "Licensing Requirements for Land Disposal of Radioactive Waste;" and 8) extend the date of expiration from December 31, 2017 to December 31, 2020.
