Dear Mr. Toelle:

I am responding to your letter AC 16-0004 dated March 14, 2016 (Agencywide Documents Access and Management Systems [ADAMS] Accession Number ML16082A363), submitting to the U.S. Nuclear Regulatory Commission (NRC) Centrus Energy Corp.'s (Centrus) Cyber Security Plan SP-HQ-0002, *American Centrifuge HQ Classified Administrative Thin Client System Security Control Security Plan, Revision 1*. The cyber security plan had been revised to reflect the relocation of Centrus' Headquarters restricted area from its current location at 6903 Rockledge Drive, Bethesda, Maryland, to the adjacent building, 6901 Rockledge Drive.

The NRC staff, in coordination with subject matter experts from the U.S. Department of Energy, Nuclear Energy Oak Ridge Site Office, has completed its review of your submittal. Based on the review of the information provided, the NRC staff approves the change to the thin client system described in Centrus' revision of the cyber security plan for processing of information up to, and including, Secret Restricted Data. However, since the change involved the physical relocation of the system, no processing of classified information is allowed until the NRC authorizes the new location for classified activities. The time period for the existing Authority to Operate for the thin client system is not affected by this revision to the cyber security plan.

Efforts under Cost Activity Code number L34361 will remain open.
