The report is required by NRC's Authorization to Operate, which was provided to Centrus on April 24, 2015 (see ADAMS Accession Number ML15113A798).

The NRC staff, in coordination with subject matter experts from the U.S. Department of Energy, Oak Ridge Site Office, conducted an initial review of your submittal. However, since the thin client system is being relocated, Centrus must provide an updated report once the relocation is completed and the system is operational. The NRC will then complete its review of the revised report and make any final determination.

Efforts under Cost Activity Code number L34361 will remain open.
