APPLICATION ONLINE REFERENCE PORTAL

Dear Mr. Chisum:

By letter dated March 23, 2016, Entergy Operations, Inc (Entergy), submitted an application for renewal of facility operating license no. NPF-38 for Waterford Steam Electric Station, Unit 3. The U.S. Nuclear Regulatory Commission (NRC) staff is currently reviewing this license renewal application (LRA) in accordance with the guidance in NUREG-1800, Rev. 2, "Standard Review Plan for Review of License Renewal Applications for Nuclear Power Plants."

In order to improve the efficiency of the NRC staff's environmental and safety reviews of the LRA, Entergy and the NRC staff have discussed the use of an online reference portal that would allow the NRC staff and associated contractors limited, read-only access to the basis documents and other reference materials cited in the LRA. The online reference portal would allow the NRC staff to audit basis documents to determine whether the information contained in the documents supports the LRA. In cases where the NRC staff identifies documents as necessary for its analysis of the LRA to document its determination in the safety evaluation report, or its development of the Environmental Impact Statement, the NRC staff will formally request those documents to be submitted on the docket.

The use of the online reference portal will be in accordance with the following restrictions:

- The online reference portal will be password-protected, and passwords will be distributed to NRC staff members and contractors directly involved in the Waterford Steam Electric Station, Unit 3, LRA review on a need-to-know basis.
- The online reference portal will not support any printing, saving, or downloading functions.
- NRC staff members and contractors given password access to the online reference portal will be informed of the conditions of use of the online reference portal by NRC project managers.
