MEETING OF THE ADVISORY COMMITTEE ON THE MEDICAL USES OF ISOTOPES

March 17-18, 2016

MEETING SUMMARY

PURPOSE

To discuss issues related to the implementation of the medical regulations in Title 10, Code of Federal Regulations (CFR), Part 35, and "Medical Use of Byproduct Material."

OUTCOME

The ACMUI made recommendations, and the U.S. Nuclear Regulatory Commission (NRC) staff gained a better understanding of the views and opinions of the ACMUI, as well as other stakeholders' views and opinions. The staff will consider these views in its continuing effort to make 10 CFR Part 35 more useful, practical, and not overly burdensome on licensees, while maintaining public health and safety.

RECOMMENDATIONS AND ACTIONS

The following recommendations and actions are a result of the discussions that took place on the topics listed on the ACMUI meeting agenda (Attachment 2).

The NRC staff will provide data to the ACMUI for medical events reported over a five-year span for trending purposes.

Dr. Alderson, ACMUI Chairman, formed a subcommittee to: 1) explore the impact of medical event (ME) reporting and its impact on self-reporting (safety culture); 2) identify potential ways to improve the effectiveness of self-reporting in support of a culture of safety; and 3) suggest ways to share ME reports and lessons learned with the medical community to promote safety. This subcommittee will present its recommendation(s) at the fall 2016 meeting. Subcommittee members include: Mr. Costello, Dr. Dilsizian, Dr. Ennis, Dr. Langhorst (Chair), and Ms. Weil. Mr. Ouhib will serve as a consultant to the subcommittee pending security clearance. The NRC staff resource is Dr. Katie Tapp.

The NRC staff will provide the ACMUI with the draft final 10 CFR 35.1000 licensing guidance for the Leksell Gamma Knife Perfexion and Leksell Gamma Knife Icon. Interested members will be encouraged to provide comments to the Working Group.

Dr. Langhorst requested that NRC staff provide the ACMUI with the total number of medical use licensees within the United States, for both NRC and Agreement States.

The Committee will contact their respective professional organizations to request and encourage interactions between the NRC and the ACMUI at their organizational meetings.

The Committee planned to hold the fall 2016 ACMUI Meeting on October 6-7, 2016 at NRC Headquarters. The back-up meeting date is September 1-2, 2016.
