SUMMARY AND ACTION REQUIRED (IF ANY)

1) Dr. Harper confirmed that there is no change to the licensed sealed source models.

2) The sealed source currently listed in Item 6.P. of the license was combined with Item 6.D. listed on the license (both are Cs-137) and listed in Table 1 under Item 6.D. of the application.

3) Dr. Harper confirmed that the Sr-90 sealed source currently listed on the license under Item 6.M contains exempt quantity only and therefore a leak test is not required.

4) The licensee provided that one or two of six survey instruments will be calibrated annually in accordance with Appendix M to NUREG-1556, Volume 7. Please provide a statement that the licensee will only use calibrated survey instrument in accordance with Appendix M to NUREG-1556, Volume 7 to conduct radiation survey and monitoring as required in 10 CFR 20.1501. In addition, please describe how the licensee provide a control to prevent users from using uncalibrated survey instruments.
