On April 8, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Surry Power Station, Units 1 and 2. The inspection covered one or more of the key attributes of the Security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on April 14, 2016, with Mr. D. Lawrence and other members of your staff.

No NRC-identified or self-revealing findings were identified during this inspection.
