PEOPLE

- Employer of Choice to more than 285 people
- During construction, UUSA logged over 17 million work hours without a lost time incident
- Industry leader in Employee Benefits and Compensation
- People's Safety continues to be our number one priority; we have had no injuries this year to date

PLANT

- When construction began at UUSA, it was the first new nuclear project in almost 30 years
- UUSA is the only producer of enriched uranium in North America
- UUSA's 60 cascades in operation, produces 4.7 million SWU making it the 4th largest production site in the world

Community

- In the past seven years, UUSA has contributed over \$1.2 million to the United Way and other community organizations
- UUSA provides the Richie Science Workshop to over 2,100 fifth graders in 20 schools each year
- UUSA awards approximately \$150,000 in student scholarships annually

Community

- UUSA routinely hosts a variety of community events such as:
 - Women's Symposium, Relay for Life, & The Robotics Expo
- 9/11 Day of Remembrance Project
 - Since 2008, UUSA has made repairs on 135 senior citizen's homes in Eunice, NM and Andrews, TX

- Safety is the cornerstone of our operations
- Safety includes industrial, nuclear, radiological and security safety
- ZERO HARM Campaign
- URENCO construction injuries were less than half of OSHA Heavy Construction average for over 18,000,000 hours worked
- Certified under ISO 9001 & 14001 keeping UUSA actively engaged in self-evaluation
- There have been no Nuclear Safety Events

Radiological Controls



- We implement comprehensive and rigorous programs for Radiation Protection, Environmental Protection, Waste Management and Transportation
- We have industry experts in these fields working at our facility
- Our programs are audited by and must comply with both NRC and State of New Mexico regulations

- We have an extensive program for Emergency Preparedness with an Emergency Operations Center along with an Alternate Emergency Operations Center and Joint Information Center in Eunice
- We routinely perform drills and emergency exercises with all of our mutual aid organizations in Lea and Andrews Counties

- UUSA has a comprehensive and rigorous program for Material Control and Accounting
- We achieved important milestones this evaluation period in our cooperation with the NRC and the International Atomic Energy Agency
- We cooperate with our government regarding support of non-proliferation
- The protection of Special Nuclear Material and Classified information is a facet of safety and a top priority
