Dear Ms. Taylor:

Enclosed is Amendment No. 27 to your NRC Material License No. 21-17007-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please note that License Condition No. 18, regarding the use of two independent physical controls, was amended because that portion of the condition is required by the regulations.

In addition, the NRC staff has reviewed the information provided and based on its review, the staff has concluded that all licensable radioactive material has been removed from your facility located at 7135 Dan McGuire Drive, Suite B, Brighton, Michigan. Therefore, this location is suitable to be released for unrestricted use. At this time we will not be able to remove the location of use in Wixom, Michigan because radioactive materials are currently stored there. After all materials have been removed, you may request to have this location removed from your license. Please be sure to include the most current leak tests for any gauges have been stored at that location in your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. You can access the policy statement and supporting material that may benefit your organization on NRC's safety culture
