SUBJECT: SUMMARY OF TELECONFERENCE TO DISCUSS OPEN ITEMS
ASSOCIATED WITH THE REVIEW OF THE ADVANCED BOILING-
WATER REACTOR CERTIFICATION RENEWAL

On Thursday, March 17, 2016, the U.S. Nuclear Regulatory Commission's (NRC) staff held a teleconference with members of GE Hitachi Nuclear Energy (GEH) to discuss responses to requests for additional information (RAI) and letters addressing open items associated with the review of the advanced boiling-water reactor certification renewal. Specifically, the following items were discussed:

1. September 25, 2015, response to RAI 08.02-2 regarding Bulletin 2012-01, "Design Vulnerability in Electric Power System"
 - a. The staff asked for clarification on how equipment is isolated from safety related busses
 - b. The staff asked for clarification on how an open phase condition is detected on the main transformer verse a degraded voltage condition
 - c. GEH requested a public meeting on April 6, 2016, to discuss revisions to this RAI
2. September 9, 2015, response to Fukushima Recommendation 4.2 Mitigation Strategies
 - a. The staff stated that the response did not contain the necessary details to clearly identify the strategies and more information was needed to perform a comprehensive review
