- (b) The contract includes direct labor hours at specified fixed hourly rates, inclusive of wages, fringe, overhead, general and administrative expenses, and profit.
- (c) The amount presently obligated by the Government with respect to this contract is \$252,340.
- (d) It is estimated that the amount currently obligated will cover performance through May 31, 2016.
- (e) This is an incrementally-funded contract and FAR 52.232-22 – “Limitation of Funds” applies.

(b) If one or more of the key personnel, for whatever reason, becomes, or is expected to become, unavailable for work under this contract for a continuous period exceeding 30 work days, or is expected to devote substantially less effort to the work than indicated in the proposal or initially anticipated, the contractor shall immediately notify the contracting officer and shall, subject to the concurrence of the contracting officer, promptly replace the personnel with personnel of at least substantially equal ability and qualifications.

(c) Each request for approval of substitutions must be in writing and contain a detailed explanation of the circumstances necessitating the proposed substitutions. The request must also contain a complete resume for the proposed substitute and other information requested or needed by the contracting officer to evaluate the proposed substitution. (d) If the contracting officer determines that suitable and timely replacement of key personnel who have been reassigned, terminated, or have otherwise become unavailable for the contract work is not reasonably forthcoming, or that the resultant reduction of productive effort would be so substantial as to impair the successful completion of the contract or the service order, the contract may be terminated by the contracting officer for default or for the convenience of the Government, as appropriate. If the contracting officer finds the contractor at fault for the condition, the contract price or fixed fee may be equitably adjusted downward to compensate the Government for any resultant delay, loss, or damage.

(b) Performance of the work under this contract is subject to the technical direction of the NRC project officer. The term technical direction is defined to include the following:

(1) Technical direction to the contractor which shifts work emphasis between areas of work or tasks, authorizes travel which was unanticipated in the Schedule (i.e., travel not contemplated in the Statement of Work or changes to specific travel identified in the Statement of Work), fills in details, or otherwise serves to accomplish the contractual statement of work.

(2) Provide advice and guidance to the contractor in the preparation of drawings, specifications, or technical portions of the work description.

(3) Review and, where required by the contract, approve technical reports, drawings, specifications, and technical information to be delivered by the contractor to the Government under the contract.

(c) Technical direction must be within the general statement of work stated in the contract. The project officer does not have the authority to and may not issue any technical direction which:

(1) Constitutes an assignment of work outside the general scope of the contract.

(2) Constitutes a change as defined in the "Changes" clause of this contract.

(3) In any way causes an increase or decrease in the total estimated contract cost, the fixed fee, if any, or the time required for contract performance.

(4) Changes any of the expressed terms, conditions, or specifications of the contract.

(5) Terminates the contract, settles any claim or dispute arising under the contract, or issues any unilateral directive whatever.

(d) All technical directions must be issued in writing by the project officer or must be confirmed by the project officer in writing within ten (10) working days after verbal issuance. A copy of the written direction must be furnished to the contracting officer. A copy of NRC Form 445, Request for Approval of Official Foreign Travel, which has received final approval from the NRC must be furnished to the contracting officer.

(e) The contractor shall proceed promptly with the performance of technical directions duly issued by the project officer in the manner prescribed by this clause and within the project officer's authority under the provisions of this clause.

(f) If, in the opinion of the contractor, any instruction or direction issued by the project officer is within one of the categories defined in paragraph (c) of this section, the contractor may not proceed but shall notify the contracting officer in writing within five (5) working days after the receipt of any instruction or direction and shall request that contracting officer to modify the contract accordingly. Upon receiving the notification from the contractor, the contracting officer shall issue an appropriate contract modification or advise the contractor in writing that, in the contracting officer's opinion, the technical direction is within the scope of this article and does not constitute a change under the "Changes" clause.

(g) Any unauthorized commitment or direction issued by the project officer may result in an unnecessary delay in the contractor's performance and may even result in the contractor expending funds for unallowable costs under the contract.

(h) A failure of the parties to agree upon the nature of the instruction or direction or upon the contract action to be taken with respect to the instruction or direction is subject to 52.233-1 - Disputes.

(i) In addition to providing technical direction as defined in paragraph (b) of the section, the project officer shall:

(1) Monitor the contractor's technical progress, including surveillance and assessment of performance, and recommend to the contracting officer changes in requirements.

(2) Assist the contractor in the resolution of technical problems encountered during performance.

(3) Review all costs requested for reimbursement by the contractor and submit to the contracting officer recommendations for approval, disapproval, or suspension of payment for supplies and services required under this contract.

ATTACHMENT 1 STATEMENT OF WORK

C.1 Title

Operations and Maintenance of the Agency-Wide NRC Physical Security System.

C.2 Background

The contractor shall provide all personnel, equipment, supplies, facilities, transportation, tools, materials, supervision, and other items and non-personal services necessary to perform operations and maintenance of NRC Security System at all NRC facilities as defined in this SOW, except for those items specified as Government-furnished property and services. The contractor shall perform to the standards in this contract/order.

This contract will support the NRC physical security system, including the physical access control system (PACS), closed circuit television (CCTV) and intrusion detection system (IDS) for the protection of NRC personnel, facilities and information.

C.3 Scope of Work

The contractor shall provide all resources and materials to perform Operations and Maintenance (O&M) of the agency-wide NRC security system in its current state. Services will include but are not limited to providing general upkeep of the system and its parts, commissioning and decommissioning equipment, providing/installing supplies and equipment, and providing training of the system. Services shall also include emergency and non-emergency repairs, provide training to NRC physical security staff, perform special projects and provide assistance with security survey support as defined in the requirements section below:

C.4 Requirements Covered Under the Firm Fixed Monthly Price

The Contractor shall be responsible for the first \$3,500 of resources and materials per incident for the cost of any repairs, training, special projects or support in this category under the fixed price basic services portion of this task order.

C.4.1. Operation and Maintenance

The Contractor shall be required to perform operations and maintenance service for each of the systems: CCTV, IDS and PACS.

The specific operation and maintenance for each system shall be specified for each individual project. Services include but are not limited to providing general upkeep of the system and its parts, commissioning and decommissioning equipment, providing and installing equipment, and providing training of the system.

CCTV

The contractor shall furnish and install fully functional and integrated equipment for new locations as determined by the NRC. The contractor shall ensure all equipment is properly maintained to operate as designed.

PACS

The current NRC PACS system is GE/Lenel. The Contractor shall provide and install new equipment based on the recommendations from the Order. The specific equipment

shall be specified at the order level. The contractor shall ensure all equipment is properly maintained to operate as designed.

IDS

The NRC currently utilizes Bosch IDS for all NRC facilities. Each Bosch panel communicates with the Homeland Security / Federal Protective Service (FPS) MegaCenters through both digital and analog means. The NRC utilizes a wide variety of intrusion sensors to include glass break, dual technology, passive infrared, and balanced magnetic switch (BMS).

All NRC Bosch IDS are Underwriters Lab (UL) 2050 IDS. The contractor shall provide O&M of existing IDS, including annual inspections and certifications. The contractor shall furnish and install fully functional and integrated UL IDS for new locations as determined by the NRC. All IDS shall report all conditions (alarms, troubles, tests, restores, openings and closings etc.) to the appropriate Homeland Security / FPS MegaCenter. The contractor shall follow the MegaCenter Alarm Requirements (MAR) document requirements for monitoring facilities. Maintenance and repair of all IDS is the responsibility of the Contractor and/or the Contractor's installer. New IDS systems must be fully functional at time of acceptance by the Government.

C.4.2 Training

The Contractor shall provide training to Division of Facilities Security, guards contractors, regional PACS administrators, and badging contractors on the CCTV, IDS and PACS systems. Any training over \$3,500 must be approved by the CO in advance.

C.4.3 Non-Emergency Repairs

The contractor shall complete non-emergency repairs to all software and hardware issues reported by the NRC COR within 48 hours after being reported (excluding weekends, holidays and Government closures). Any repairs over \$3,500 must be approved by the CO in advance.

C.4.4 Emergency Response and Repairs

The contractor shall provide emergency response by a highly trained and capable technician to NRC facilities within four (4) hours after notification that the system is malfunctioning to bring the system back online within four (4) hours of system failure. Any repairs over \$3,500 must be approved by the CO in advance, however it is the CO's discretion to authorize the Contractor to proceed without obtaining formal written approval.

C.4.5 Special Projects

The contractor shall perform special projects regarding the installation, relocation, removal, or reconfiguration of individual security system components from existing, planned or new NRC facilities as they are incorporated into or deleted from NRC facilities under the direction of the NRC COR. This includes the integration of all new or relocated security system components into the head end unit to include programming the head end unit. Any special projects in excess of \$3,500 will require prior approval from the NRC CO.

C.4.6 Facilities Security Survey Support

The contractor shall provide facilities security survey support at NRC facilities. This includes testing of security system components per the direction of the security survey lead.

C.4.7 Other Materials

The contractor shall also provide necessary materials for the ongoing operations and maintenance of the NRC Physical Security System. Prices for Annual UL 2050 Certificate and Annual Facility Commander Software Support Agreement are established in the Base Contract Price Schedule.

C.5 Requirements exceeding the Firm Fixed Monthly Price

In the event the Contractor, prior to or while performing repairs determines that the cost shall exceed the \$3,500 repair limit, the Contractor shall first obtain CO's approval for work over \$3,500 before continuing such repair work. If the Contractor proceeds without having first obtained approval, the Government shall not be liable for reimbursement to the Contractor for the amounts in excess of \$3,500. Costs for repairs above \$3,500 will be reimbursed by the Government under the labor hours and reimbursable services portion of this contract.

The written request will include a breakdown of the labor and materials needed to perform the work. If the materials are included in the list of materials of this task order, the contractor shall quote the agreed upon price. If the material needed is not in the task order materials list but is included in the contractor's GSA schedule, the contractor shall honor the GSA schedule price, discounts are encouraged. For any items that are not included in contractor's GSA schedule price, to show they are obtaining materials at the most advantageous prices available, the contractor will be required to provide copies of three quotes or price lists. Any such goods purchased repetitively will be incorporated into the Price Schedule by bilateral modification. The materials list can also be adjusted during contract administration at contractor's request to add additional parts needed following the guidance above. The CO may waive the requirement for three quotes or price lists on a case-by-case basis

If during task order administration, the government finds a discrepancy between the contractor's GSA current price and the price agreed on the materials list, the contractor shall honor the lowest price.
