Subject: Notice of Disbursement from Decommissioning Trusts

Dear Sir,

In accordance with the various facility operating licenses, the decommissioning trust agreement provides that no disbursement shall be made by the Trustee unless the Trustee has first given the Director of the Office of Nuclear Reactor Regulation 30 days prior written notice of such disbursement.

In addition, Article III, Section 3.01, "Distributions", of the Second Amended and Restated Nonqualified Nuclear Decommissioning Master Trust Agreement and the Second Amended and Restated Qualified Nuclear Decommissioning Master Trust Agreement provides that distributions will be made in accordance with Article 3 of the Master Terms. The Master Terms for Trust Agreements Article 3, Section 3.01, "Use of Assets", paragraph (b), provides that except for administrative costs and taxes as provided in Section 3.03 of the Master Terms, no disbursement or payments for decommissioning costs shall be made from the trusts unless the Trustee provides 30 days' prior written notice to the NRC Director, Office of Nuclear Reactor Regulation.

This letter provides the Director of the Office of Nuclear Reactor Regulation written notification of The Northern Trust Company's intent to make disbursements from the trust for the below Units:

The transfer of funds will reimburse Exelon Generation Company LLC (EGC) for decommissioning costs of \$3,540,136.72 incurred on behalf of the previously listed units. EGC has confirmed to us that the costs to be reimbursed were related to the decommissioning planning and administrative expenses and were allowable decommissioning expenses for the period of January 1, 2001 thru December 31, 2014.

In addition, this letter provides written notification of the Northern Trust Company's intent to make disbursements from the trusts for Dresden 1, Facility Operating License No. CPR-2, to reimburse EGC for decommissioning costs of \$27,763,464.96 incurred for the years 2006 thru 2014

We plan to make distribution to EGC from the Nonqualified and Qualified Nuclear Decommissioning Trusts in the amounts described above after 30 days following the date of this letter, in the absence of any written notice of objection from the NRC.
