Was curious if you or your legal teams are aware of this law that was passed last year and that takes effect on June 1? I am the NRC's working group member on complying with this issue for the NRC (with help from OGC and other offices). Currently I am working with OMB – the lead agency – and 14 other Agencies on this issue.

Please let me know if you are or aren't familiar with this and if you would like to discuss.

Bottom line is that there are some implications of your COLAs being placed on a publicly available Dashboard as of June 1 as well as other requirements.

I have copied Kaitlin Rekola from NEI's legal group who I have corresponded with also (you may want to contact her if you haven't done so already).
