The purpose of this letter is to provide an errata page to Revision 4 of the Early Site Permit Application (ESPA) for the PSEG Site provided in Reference 1 above. This errata page updates the list of figures provided in Chapter 2, Site Characteristics and Site Parameters, of the Site Safety Analysis Report (SSAR), as submitted in Part 2 of the PSEG Site Early Site Permit Application, Revision 4.

PSEG identified an oversight in the submittal of responses (References 3, 4, 5 and 6) to the request for additional information (RAI) provided in Reference 2 above. The responses to RAI No. 61 deleted SSAR Figures 2.5.2-1 through 2.5.2-17 from the ESPA. The SSAR Chapter 2 list of figures was not updated to reflect the deletion of these figures from the ESPA in subsequent ESPA revision submittals.
