SUBJECT: BROWNS FERRY NUCLEAR PLANT, UNITS 1, 2, AND 3 – REQUEST FOR
WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
(CAC NOS. MF6741, MF6742, AND MF6743)

Dear Mr. Shea:

By letter to the U.S. Nuclear Regulatory Commission (NRC), dated April 4, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16095A293), Tennessee Valley Authority submitted an affidavit dated March 22, 2016, executed by Mr. Alan B. Meginnis, Manager, AREVA, Inc. (AREVA), requesting that the information contained in the following proprietary document (Enclosure 1 of the letter dated April 4, 2016) be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

ANP-3474P, Revision 0, "Response to RAIs [Requests for Additional Information] for Browns Ferry Nuclear Plant EPU [Extended Power Uprate] Submittal – Reactor Systems Branch Questions," March 2016

A nonproprietary copy of document ANP-3473NP, Revision 0 (Enclosure 2 of the letter dated April 4, 2016), entitled "Response to RAIs for Browns Ferry Nuclear Plant EPU Submittal – Reactor Systems Branch Questions" (Non-proprietary version), March 2016 has been placed in the NRC's Public Document Room and added to the NRC Library in ADAMS under Accession No. ML16095A293.

The AREVA affidavit dated March 22, 2016, stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (b) Use of the Information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- (d) The Information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA in product optimization or marketability.
- (e) The information is vital to a competitive advantage held by AREVA, would be helpful to competitors to AREVA, and would likely cause substantial harm to the competitive position of AREVA.
