Dear Mr. Albritton:

On May 5, 2016, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of Honeywell Metropolis Works at Metropolis Community Center, 900 West 10th Street Metropolis, IL. The purpose of the meeting was to discuss the results of the NRC's assessment of Honeywell's safety performance for the review period of January 1, 2014, through December 31, 2015. The meeting notice and agenda, dated April 20, 2016, are available in the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession No. ML16111A261. A list of attendees is enclosed.

The NRC staff presented its evaluation of your safety performance in the areas of safety, radiological controls, and facility support, as discussed in the March 7, 2016, letter (ADAMS Accession No. ML16067A263) (See ADAMS Accession No. ML16131A641).

The licensee acknowledged the assessment results and presented information on the site's plant status, updates, and path forward. (See ADAMS Accession No. ML16131A640).
