On March 12, 2012, the NRC issued Reference 1, which included a request for information associated with Near-Term Task Force (NTTF) Recommendation 2.1 for flooding. Enclosure 2 of Reference 1 addresses the Requested Information and Required Response. The NRC Staff requested licensees to perform a flood hazard reevaluation (Requested Information Item 1) and to provide a final report documenting the results in accordance with the NRC's prioritization plan (Required Response Item 2). On May 11, 2012, the NRC issued the prioritization plan (Reference 2). Reference 2, Enclosure 1, identified Prairie Island Nuclear Generating Plant (PINGP), Units 1 and 2, as a Category 2 site requiring a response by March 12, 2014.

By the Reference 3 letter, Northern States Power Company, a Minnesota corporation (NSPM), d/b/a Xcel Energy, requested NRC assistance to obtain information needed to complete the Flood Hazard Reevaluation Report (FHRR) for PINGP from the United States Army Corps of Engineers (USACE). NSPM requested that NRC act as interface between the USACE and NSPM to obtain the necessary information. In the Reference 4 letter, NSPM requested an extension for the completion and submission of the FHRR from March 12, 2014 to within ten months of receiving the USACE's final information.

The NRC revised the required response date (Reference 5) for the PINGP FHRR to six months after NSPM received the USACE final analysis. The NRC transmitted the USACE flood hazard information necessary for NSPM to complete the FHRR for PINGP in a letter dated November 18, 2015 (Reference 6). In the Reference 6 letter, the NRC identified that the PINGP FHRR is due by May 16, 2016.

The purpose of this letter is to provide the FHRR for PINGP, Units 1 and 2. The PINGP FHRR is enclosed. Direct responses to the Reference 1, Enclosure 2, Requested

Information, Item 1, are included in Appendix 1 of the PINGP FHRR. No interim actions are necessary.

Enclosure 1 of this letter is being submitted as containing "Security-Related Information – Withhold under 10 CFR 2.390." NSPM hereby requests that Enclosure 1 be withheld from public disclosure in accordance with the provisions of 10 CFR 2.390. A redacted version of Enclosure 1 is provided in Enclosure 2.
