The NRC staff determined efficiency gains would be realized by auditing the documents supporting the design calculations presented in the APR 1400 design control document (DCD) in lieu of requests for additional information (RAIs) that the applicant docket the calculation files. The purpose of this audit is to allow the NRC technical staff to verify that design analyses follow the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR), Section 50.55a, and are consistent with the descriptions in the DCD.
