Advisory Committee on Reactor Safeguards Meeting with Entergy Corporation Regarding Grand Gulf Nuclear Station, Unit 1 License Renewal Safety Evaluation Report

On May 4, 2016, the staff and Entergy Operations, Inc., met with the Advisory Committee on Reactor Safeguards to discuss the Grand Gulf Nuclear Station, Unit 1, License Renewal Application and Final Safety Evaluation Report (SER). The SER contains no open items. The staff expects to publish the "Safety Evaluation Report Related to the License Renewal of Grand Gulf Nuclear Station, Unit 1," as a NUREG in November 2016.

Public Meeting with Industry Risk-Informed Steering Committees

On May 10, 2016, the staff and Industry Risk-Informed Steering Committees (RISCs) participated in a public meeting to continue discussions on risk-informed areas of interest. The committees received a brief update on the status of the probabilistic risk assessment (PRA) Technical Adequacy Working Groups including the recently-held public workshop. The RISCs received an update on efforts pertaining to crediting mitigating strategies in risk-informed decision-making, including the next steps in the review of the Nuclear Energy Institute (NEI)-submitted white papers, providing a response to NEI in June, and development of guidance to supplement the white papers. The RISCs had a discussion on the use of licensee PRA models vice Standardized Plant Analysis Risk (SPAR) models in regulatory processes with both groups expressing support for continued discussions. The RISCs received the proposed next steps for the potential pilot program. The industry presented to the committees their desire to ensure practical guidance for the risk aggregation across hazards. Industry also presented their desire to streamline 10 Code of Federal Regulations (CFR) Part 50.69 submittals.
