Subject: Request for Additional Information; Amendment ltr dtd March 30, 2016

Discussion: Mr. Cain was contacted to request additional information regarding the amendment letter. Specifically, I requested information regarding the types and quantities of material requested in the application as the materials were not as currently authorized on the license. I asked if the licensee had moved to the new location. Mr. Cain said they had moved two weeks ago and the previous location was unconditionally released. I asked if ECS's North Carolina license had been amended and he said it had not and he was responding to a request for information from the NC Licensing program. I asked that he resubmit the amendment request and include the types and amounts of material ECS will need authorization for in NRC jurisdiction, and to provide information on the current location (diagram). I informed Mr. Cain that they would need to evaluate the dose to members of the public at the new location. I also asked if the licensee's program or procedures had been revised regarding gauge security, transport, and storage when at temporary jobsites in NRC jurisdiction. He said nothing had changed. He said he would revise the amendment letter and resubmit for review within two days.
