SUBJECT: SUMMARY OF MAY 11, 2016, PUBLIC MEETING TO DISCUSS

TORNADO GENERATED MISSILE PROBABILISTIC ANALYSIS

On May 11, 2016, a Category 2 public meeting was held between U.S. Nuclear Regulatory Commission (NRC) staff and stakeholders, at NRC headquarters. The purpose of the meeting was to seek input from stakeholders, and to discuss working group coordination efforts that will review the use of probabilistic methods of analysis for tornado-generated missile protection with deterministic license amendments.

The meeting began with opening remarks from the Director, Division of Risk Assessment. He discussed how the NRC wanted to move the conversation forward in a meaningful way.

The Nuclear Energy Institute (NEI) gave a presentation titled, "NEI Tornado Missile Risk Evaluator (TMRE)" (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16132A118). In the presentation, NEI discussed the TMRE process and how it worked, as well as all supporting requirements that will be included in the TMRE methodology. Some questions that NRC staff asked during a March 23, 2016, meeting were also discussed. Throughout the meeting, NRC staff asked NEI to clarify points made in the presentation.

The next topic of discussion was a draft license amendment template (ADAMS Accession No. ML16138A006) created by NRC staff. The template was created in order to assist licensees with the submission of a license amendment request regarding tornado missile considerations. NEI asked several questions in order to clarify some of the information in the template.

NEI also discussed NRC staff recommendations regarding determination of missile impact probability (ADAMS Accession No. ML16131A001).

The possibility of extending the Enforcement Guidance Memorandum (EGM 15-002) from a three (3) year discretion period to five (5) years (for plants located within Regulatory Guide 1.76 Region 1) was discussed, as well as how licensees may request the extension if necessary. The meeting ended with a discussion on the path forward for the TMRE methodology.
