By letter dated April 28, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16124A794), South Carolina Electric & Gas Company (SCE&G) submitted a license amendment request (LAR) for the Virgil C. Summer Nuclear Station, Unit No. 1. The proposed change would have deleted the Limiting Condition for Operation (LCO) note associated with Technical Specification 3.5.4, "Refueling Water Storage Tank." Subsequently, by letter dated May 25, 2016 (ADAMS Accession No. ML16152A163), SCE&G withdrew the LAR.

As discussed in a conference call with your staff on May 16, 2016, the NRC staff stated that the LAR provided insufficient detail to enable the staff to complete its review. Specifically, the request did not include information related to procedure changes associated with the physical plant modification and removal of the LCO note.

The NRC staff acknowledges your request to withdraw the application and has ceased activities on the review and closed the associated cost activity code.
