

In a letter dated October 30, 1996, Duke Power submitted revised Bases pages for the Oconee Technical Specification Section 3.7. The revised Bases pages were not incorporated into the Oconee Technical Specification change request dated February 15, 1996, which was approved by an NRC Safety Evaluation Report dated March 20, 1997. In order to prevent duplication or elimination of the Bases information, Bases pages 3.7-13 and 3.7-15 were reformatted. When combined with the approved Technical Specification amendment, dated March 20, 1997, the attached pages ensure that no changes to the Bases are made beyond those evaluated in the associated safety evaluation report.
