SUBJECT: FINAL RULE: REVISION OF FEE SCHEDULES; FEE
RECOVERY FOR FISCAL YEAR 2016

A copy of the *Federal Register* notice of a final rulemaking, Revision of Fee Schedules; Fee Recovery for Fiscal Year (FY) 2016 is enclosed. The notice describes the U.S. Nuclear Regulatory Commission's amendments to the licensing, inspection and annual fees charged to its applicants and licensees.

It is requested that the Office of Nuclear Material and Safety Safeguards notify the Agreement States to distribute this final rule to their licensees. The rule does not change the Title 10 of the *Code of Federal Regulations* (10 CFR) Part 170 fees currently assessed to those Agreement State licensees who perform work in non-Agreement States under the reciprocity provisions of 10 CFR 150.20. For FY 2016, the reciprocity fee remains unchanged from \$1,900 in FY 2015.
