## **SUMMARY**

By letter dated March 4, 2016, BWXT Nuclear Operations Group, Inc. requested an amendment to Certificate of Compliance No. 5086, for the Model No. UNC-2600 transportation package. The letter requested name changes to the subject certificate of compliance due to a recent company name change. The certificate has been updated to Revision No. 15 to reflect the changes.

## **EVALUATION**

The purpose of the amendment was to change the name of the entity the certificate of compliance is issued to from "Babcock & Wilcox Nuclear Operations Group, Inc." to the new name "BWXT Nuclear Operations Group, Inc." BWXT Nuclear Operations Group, Inc. also submitted a consolidated safety analysis report for the package dated March 4, 2016.

The company name changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

## **CONDITIONS**

The following changes have been made to the certificate of compliance:

Section 3.a. of the certificate of compliance has been revised to reflect the new name of the certificate holder, "BWXT Nuclear Operations Group, Inc." as requested.

Sections 6(a) and (b) have been updated to the application date (March 4, 2016).

Condition No. 9 now allows use of Revision No. 14 of the certificate until June 30, 2017.

The References section has been updated to include the name change request.

## **CONCLUSION**

Based on the statements and representations in the amendment request, the staff finds that these changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
