Our review of the subject portion of the Levy FSER resulted in the following minor comments, which we are forwarding to you for NRC consideration to determine necessary resolution.

1. Section 1.5.5.1.4 should reference a later submittal after the 9-18-14 Levy RAI Letter 120 Response submittal. That submittal was later supplemented by a 11-20-14 update from Duke (NPD-NRC-2014-040).
2. Page 1-75, Under the paragraph following: Applicable Requirement: 10 CFR 73.67 (a) (2) (iii): The following statement should be revised as shown:
  - a. "Also, DEF has described the process for receiving and placing SNM in Sections 5.11, "Receipt of Non-Fuel SNM, " and Section 5.12 (for fuel SNM) of its SNMPPP."  
To
  - b. "Also, DEF has described the process for receiving and placing SNM in Sections 5.1.1, "Receipt of Non-Fuel SNM, " and Section 5.1.2 (for fuel SNM) of its SNMPPP."
