The decommissioning survey plan, entitled "CDC RAW Room #1 Decommissioning Plan" dated April 20, 2016, is approved for use in releasing Chamblee Building 1, radioactive waste room #1 at 4770 Buford Highway, Chamblee, Georgia for unrestricted use. Condition 20 was amended to your license to authorize the site specific derived concentration guideline levels. Once the survey is completed, please submit the survey information to release the facility.
