


- 1. Based on the inspection findings, no violations were identified.

10 CFR 20.1101(c) requires the licensee shall periodically (at least annually) review the radiation protection program content and implementation. Contrary to the above, the licensee did not periodically (at least annually) review the radiation protection program content and implementation. Specifically, as of October 28, 2015, annual reviews had not been performed for 2012, 2013, and 2014. The licensee's corrective actions included completing an annual review and maintaining a scheduler for future audits. Corrective actions are considered completed and a reply is not required.

This is a Severity Level IV violation (Enforcement Policy Section 6.3.d.3).

**Statement of Corrective Actions**

I hereby state that, within 30 days, the actions described by me to the Inspector will be taken to correct the violations identified. This statement of corrective actions is made in accordance with the requirements of 10 CFR 2.201 (corrective steps already taken, corrective steps which will be taken, date when full compliance will be achieved). I understand that no further written response to NRC will be required, unless specifically requested.
