Subject: False Negative Blind Urine Drug Screen

A blind urine specimen, Requisition #303826 was submitted by Duke Power from Catawba Nuclear Station to SmithKline Beecham Laboratory in Atlanta on May 24, 1991. The blind specimen contained both cocaine and marijuana metabolites at the concentration of 450 ng/ml and 150 ng/ml respectively. The specimen was reported to Duke Power on May 28, 1991 as positive for marijuana at the 100 ng/ml and 50 ng/ml cut off level. However, it was reported as negative for cocaine.

Dr. McHan notified the laboratory of the result and asked them to investigate the error and repeat the specimen on June 13, 1991. Ben R. Wells, Technical Manager of the SmithKline Beecham Laboratory contacted my office that day. I returned his call the next day and he informed me of the result and that repeat of the test was positive for cocaine. Dr. McHan notified me of the result, also.

Mr. Wells stated that the specimen tested positive on the original (EMIT) screening, but that it did not confirm on the GC-MS methodology.

There was not a sample mix up and he believes the negative report "is attributable to a random occurrence in the extraction process". Please see the enclosed letter of investigation and report. He has assured me that any specimens that are positive for marijuana or cocaine on EMIT, but do not confirm on GC-MS, will be scrutinized closer in the future and procedures have been implemented.

In summary, a blind specimen contained marijuana and cocaine was submitted. Marijuana was identified correctly. Cocaine was identified on the EMIT test, but did not confirm on GC-MS. Repeat analysis correctly identified cocaine. Procedures have been implemented to prevent the recurrence of this error.

SUBJECT: FALSE NEGATIVE BLIND RESULT

DEAR DR. DUKES,

I AM WRITING TO INFORM YOU OF A FALSE NEGATIVE RESULT ON A BLIND SAMPLE (REQ.# 3038286) SUBMITTED BY YOU ON MAY 25, 1991. THE SAMPLE HAS BEEN REANALYZED AND FOUND TO BE POSITIVE FOR BENZOYLECGONINE. THE ORIGINAL SCREENING TEST DID INDICATE A PRESUMPTIVE POSITIVE FOR BENZOYLECGONINE. HOWEVER, THE SUBSEQUENT CONFIRMATION TEST DID NOT CONFIRM THE PRESENCE OF THAT COMPOUND. THUS, THE REPORT YOU RECEIVED STATED THAT THE SPECIMEN WAS NEGATIVE FOR COCAINE. UPON REANALYSIS, THE PRESENCE OF BENZOYLECGONINE WAS CONFIRMED IN THE SAMPLE.

OUR REVIEW OF THE ADDITIONAL SAMPLES, CONTROLS, AND IN-HOUSE BLINDS ON THE INITIAL RUN DOES NOT INDICATE THAT SPECIMEN INTEGRITY WAS BREACHED IN ANY FASHION. WE BELIEVE THE INITIAL NEGATIVE REPORT IS ATTRIBUTABLE TO A RANDOM OCCURRENCE IN THE EXTRACTION PROCESS. PLEASE BE ASSURED THAT PROCEDURES HAVE BEEN INSTITUTED TO PREVENT SUCH AN OCCURRENCE IN THE FUTURE.
