In a telephone conversation on April 18, 1995, Paul Stovall, Director of Operator Training, and George Hopper, License Examiner, Region II Operator Licensing Section, made arrangements for the NRC to inspect the licensed operator requalification program at the Oconee Nuclear Station. In order for the NRC to adequately prepare for this inspection, please furnish the written examinations and operating tests scheduled for the week of the inspection to the NRC by May 9, 1995.

The request for requalification examination material is covered by Office of Management and Budget (OMB) Clearance Number 3150-0101, which expires on October 31, 1995. The estimated average burden is 4.0 hours per response, including gathering, copying, and mailing the required material.
