On May 6, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Seabrook Station. The NRC inspectors discussed the results of this inspection with Mr. Ralph Dodds, Plant General Manager, and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
