This memorandum documents the US Nuclear Regulatory Commission (NRC) periodic review of Regulatory Guide (RG) 5.79, "Protection of Safeguards Information," published in April 2011. The RG describes a method that the staff of the NRC considers acceptable for use in implementing the general performance requirements for the protection of Safeguards Information, as defined in Title 10 of the *Code of Federal Regulations*, Part 73, "Physical Protection of Plants and Materials." As discussed in Management Directive 6.6, "Regulatory Guides," the NRC staff reviews RGs approximately every 5 years to ensure that the RGs continue to provide useful guidance. Documentation of the NRC staff review is enclosed.

Based on the results of the periodic review, the staff concludes that no changes to RG 5.79 Revision 0 are warranted. The staff did not identify any technical or regulatory issues in the review.
