On March 31, 2016, a webinar was held to attain feedback from NRC stakeholders on the effectiveness of the requirements in Title 10 of the *Code of Federal Regulations* (10 CFR) Part 37, "Physical Protection of Category 1 and Category 2 Quantities of Radioactive Material," and associated guidance documents.

The feedback received during the webinar will be used to inform the ongoing assessment of the effectiveness of 10 CFR Part 37. The results of the staff's assessment will be reported to Congress in December 2016.

In order to encourage stakeholder feedback on the rule and associated guidance documents, specific questions were provided in a *Federal Register* Notice (81 FR 13263) that was issued on Monday, March 14, 2016. These questions were used to facilitate discussion during the webinar.

A total of 178 stakeholders participated in the webinar. A list of the meeting participants is provided in Enclosure 2. The staff received 25 comments relating to 10 CFR Part 37 and its associated guidance documents during the webinar. These comments are summarized in Enclosure 3.

Stakeholder Comments

The NRC received 25 comments from stakeholders during the webinar:

- Four comments were related to clarification related of the Local Law Enforcement Agency (LLEA) requirements. These comments covered the expectations of a reasonable LLEA agreement and guidance related to LLEA notifications that also require a notification to the regulatory agency;
- Fourteen comments were related to the trustworthiness and reliability (T&R) process. These comments were related to alignment of requirements in 10 CFR Parts 37 and 73; guidance for third party arbitration; relief of some T&R background investigation requirements for hired police officers and individuals who have received a Federal background check; frequency of criminal history checks; establishment of a for-fee background check service by the NRC; clarification related to individuals requiring T&R determinations; clarification of information required for 7-year period review, clarification for where to submit information on newly approved Reviewing Officials; provisions for information sharing between licensees for T&R determinations; and guidance to support licensees with bifurcated T&R processes involving Human Resources; and
- Seven comments were related to communications between the regulators and licensees regarding writing of clear and succinct requirements and guidance; early stakeholder feedback for guidance and requirements; providing samples of T&R-related letters; and providing expectations for inspection oversight.
