SUBJECT: SUMMARY OF MAY 5, 2016, 10 CFR PART 37 ASSESSMENT
PUBLIC MEETING AND WEBINAR

On May 5, 2016, a public meeting was held at NRC Headquarters in Rockville, Maryland, to attain feedback from NRC stakeholders on the effectiveness of the requirements in Title 10 of the *Code Federal Regulations* (10 CFR) Part 37, "Physical Protection of Category 1 and Category 2 Quantities of Radioactive Material," and associated guidance documents. The feedback received during the meeting and the associated webinar will be used to inform the ongoing assessment of the effectiveness of 10 CFR Part 37. The results of the staff's assessment will be reported to Congress in December 2016.

In order to encourage stakeholder feedback on the rule and associated guidance documents, specific questions were provided in a *Federal Register* Notice (81 FR 13263) that was issued on Monday, March 14, 2016. These questions were used to facilitate discussion during the meeting.

A total of 27 stakeholders participated in the webinar. A list of the meeting participants is provided in Enclosure 2. The staff received eight comments relating to 10 CFR Part 37 and its associated guidance documents during the meeting. These Comments are summarized in Enclosure 3.

Stakeholder Comments

Public Meeting

The NRC received 8 comments from stakeholders during the public meeting:

- Four comments were related to the trustworthiness and reliability (T&R) process and included comments and questions in the areas of extensiveness of T&R determinations that do not require fingerprinting; what information is required for the 7-year period review; when the start of the 7-day determination period to remove unescorted access for individuals occurs; and expectations for background checks for individuals from foreign countries;
- Two comments were related to the control of sensitive information;
- One comment was related to clarification of requirements for continuous monitoring of Category 1 sources and weekly verification of Category 2 sources; and
- One comment was related to training.
