Discussion: (08:30) I spoke about the licensee's April 19, 2016, response to the NRC's March 15, 2016, Notice of Violation. I confirmed with Mr. LeClair that no activities conducted out of the Dover, NH facility at temporary jobsites were conducted in areas of exclusive Federal jurisdiction. I asked Mr. LeClair if the mention of the Dover, NH facility was a mistake because the NRC's correspondence dated March 15, 2016, only indicated that the utilization logs of the Worcester, MA field office were incomplete. Mr. LeClair admitted that he had made an error, that John Turner would be informed, and that an individual would be delegated the responsibility of ensuring that the corrective and preventive actions were completed at the Worcester, MA field office. I informed Mr. LeClair that I would be making a telephone conversation record and add our understandings to my acknowledgement letter. No further reply would be required of the licensee.
