

The Oconee Nuclear Site is in the process of updating our emergency classification scheme in accordance with recent guidance provided by the Nuclear Regulatory Commission (NRC) in Reg. Guide 1.101 (NUMARC/NESP-007, Rev. 2). Our submittal was made to the NRC on May 5, 1994. Our classification scheme will not be changed until approval has been received from the NRC, the State of South Carolina, and Pickens and Oconee Counties.

Reg. Guide 1.101 and 10 CFR 50 both require for the state and counties to review our emergency action levels for declaring emergency events. A copy of the proposed classification procedure is attached for your review and approval. As additional information, this classification scheme is the same as that recently adopted by the Vogtle Nuclear Site.
