

In a Response to Violation letter dated April 3, 1987 for the subject Inspection Report, a number of corrective steps to avoid further violations were specified. Included was a commitment to revise Oconee pipe specifications to include a section on cold springing. This has been completed. The second part of this commitment was to train Mechanical Maintenance Engineers on the requirements to cold spring a pipe. The completion of this corrective step was dependent on the pipe specification change, therefore due to the recent completion of the change, the training will be completed by September 1, 1987.
