Additionally, FPL and the NRC Staff have been engaged in interactions with respect to the information submitted in Reference 1. As a result of these interactions, FPL supplemented its original response in References 3, 4, 5 and 6, dated October 28, 2013, May 9, 2014, October 29, 2015, and February 12, 2016, respectively. An NRC audit of the WEC calculations was held this year on March 28 through March 30, and April 11 through April 13. The audit was attended by Westinghouse Electric Company (WEC) and FPL personnel. A discussion of the audit results is provided in the nonproprietary Enclosure 2, and a proprietary Enclosure 3, "Supplement to eRAI-6544, TPG-GW-GLR-002," Revision 4, which contains Westinghouse Proprietary Class 2 information.

In this letter, FPL provides further supplements to those previous responses with a new Appendix C of the previously submitted Enclosures 2 and 3.

FPL provides, as Enclosure 4 to this letter, new associated COLA revisions as part of this supplemental submittal to NRC's RAI 03.05.03-34. The enclosure identifies changes that will be made in a future revision of the Turkey Point Units 6 and 7 Combined License Application.

The Westinghouse proprietary information for which withholding is being requested is further identified in the affidavit signed by Westinghouse Electric Company, LLC (Enclosure 1). The Westinghouse affidavit sets forth the bases on which the information may be withheld from public disclosure by the Commission and addresses with specificity the considerations listed in 10 CFR 2.390(b)(4). Enclosure 2 is a redacted version of Enclosure 3 and is therefore non-proprietary.
