On May 19, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection at the decommissioning Zion Nuclear Power Station using Temporary Instruction (TI) 2800/041, "Title 10 of the *Code of Federal Regulations* (CFR) Part 37, Physical Protection of Category 1 and Category 2 Quantities of Radioactive Material at Facilities with a 10 CFR Part 73 Physical Protection Program," Revision 1. The results of the inspection were discussed with Ms. Eileen Moore and other members of your site licensing and security management staff at the conclusion of the inspection on May 19, 2016. The inspector documented the results of the inspection in the enclosed inspection report.

The inspection examined activities conducted under your license as they relate to security and compliance with the NRC's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel. The enclosed inspection report documents the inspection results.

No findings were identified during this inspection.
